#### 4. MATTERS ARISING FROM THE MINUTES

<u>Solton Manor</u> —The recent planning application remains undecided. A revised plan showing changes to the event barn frontage had been submitted. Event activities can be sent to DDC.

<u>East Langdon and West Langdon village greens</u>
Following discussion with Mr Macintyre,

the relocation of the Pam McIntyre memorial seat to West Langdon will go ahead.

**East Langdon Village Pond and Highways Flooding**—Awaiting plans from KCC Highways. **Martin Mill Parking issues** — Cllr A Minns has produced a highly detailed report and a 3-page summary. The report will be sent to the CEO and senior managers of southeastern. Copies will also go to our DDC ward and KCC councillors, and local MP. The resident's parking permit notice has been revised and Cllr B Price-Stephens will issue copies to Martin Mill car users.

<u>KCC</u> –Website hosting and creating an accessibility-compliant site. A 3-year web management and hosting contract has been signed with Cantium Business Services, Maidstone as proposed under Resolution 20-02/01).

<u>Annual Toad Migration at East Langdon Pond.</u> The recent 3-week period of toad and frog migration to East Langdon pond is almost finished. Thanks go to the field volunteers from the Kent Reptile and Amphibian Group who led the nightly rescue and survey visits.

<u>Purchase of new notice board – (Res 20-02/04)</u> The new notice board has arrived. The board will be installed at West Langdon or Martin after the commissioning of a parish name header.

Offer to purchase a printer /photocopier for public use in parish hall. A local resident has purchased the laser copier and will make it available for parish and community printing at cost.

# Commonwealth Day Monday March 9th

Langdon Primary class 5/6 pupils did an excellent job in reading the Commonwealth Day affirmation messages and raising the flag. It is hoped that more residents will attend this annual event in future. The pupils have been invited to display examples of their extended world geography project in the parish hall.

#### 5. HEALTH AND SAFETY

**Coronavirus Pandemic**: The evolving spread of the virus is likely to affect all aspects of daily

life including parish council meetings and business continuity. The Government and Public Health England are publishing guidelines, changes to legislation and health advice on a daily basis. The parish council should make provision to use delegated authority powers as included in The Standing Orders to carry out essential administrative, financial and business continuity functions without a public council meeting. Speeding traffic through the village is still a great concern. Cllr C Shaw has spoken to some local residents to reinforce the message of the 20mph speed limit and driving with due consideration for pedestrians and children playing. The police are aware of the speeding problems. Cllr M Bates said any speeding taxi vehicles should be reported to DDC with their details.

Press release regarding new Council Tax of 3.9% has been released making Dover District the lowest in Kent. DDC has identified the new Whitfield – Dover Rapid Transport system and Deal's Tides Leisure Centre rebuild/refurbishment as priority capital projects. DDC has decided to close the East Kent Housing and deliver housing services themselves after discovering problems with some health and safety procedures.
