6. COUNCILLOR ROLES AND RESPONSIBILITIES

Councillors will be encouraged to take on watching briefs for various community topics that they feel they are best suited to undertake. A list will be circulated ready for discussion at the next meeting and responsibilities assigned.

The KALC Dover Area Committee nominated members have been agreed as Cllr A Minns and Cllr C Shaw plus other councillors able to attend selected meetings.

7. MATTERS ARISING FROM THE MINUTES

<u>Ending of WW1 - centenary events memorial on the green</u>. - The sundial will be shipped during week of 17th June and onward to the stone masons for fitting to the memorial top. Installation will in the near future and Cllr Shaw will co-ordinate the works and alignment of the sundial. A date for a public dedication ceremony is yet to be finalised.

<u>Planning enforcement</u> - 22 Westside East Langdon. DDC Planning is aware of the front porch construction but have decided not to take any further action.

<u>Westside</u>, <u>East Langdon</u> - Hedge and tree trimming discussion. The clerk will contact Velcourt Farms who manage the land to discuss possible tree and hedge management.

8. HEALTH AND SAFETY

Overgrown verges are still of concern. Cllr A Minns has again written to KCC outlining our concerns and is awaiting a response. The issue of cars speeding through the lanes has heightened due to the overgrown hedges. People walking the lanes and children going to school are at greater risk, often obscured by hedge growth and sometimes forced into the untrimmed stinging nettles and brambles to avoid passing cars.

Community Warden Services for St Margaret's and Langdon parishes. Lee Kidd (area team leader) reported that a recently-recruited community warden will be allocated to our area in early July after training.

Area PCSO visibility - PCSO Oliver Parker explained that due to lack of team manpower and priority service responses he has been unable to attend parish meetings.

Joint Dover Transportation Board

Cllr A Minns reported on scheduled road closures on the A258, due to start 12/9/2019.

Each of the two projects will last over 2 days. In light of the major traffic hold-ups at the A258 works in Upper Walmer, the July and September works will be completed at night to reduce traffic delays and motorists using rat-run routes through the local villages.
