3. MINUTES

4. MATTERS ARISING FROM THE MINUTES

Solton Manor – See item 10. Planning

West Langdon village green and memorial seat

On East Langdon Green the circular memorial seat which surrounds a large birch tree is being damaged as the tree girth increases. The seat, which is dedicated to the late parish councillor Pam Macintyre, cannot be enlarged. A proposal is to relocate the memorial seat to West Langdon Green as the Macintyre family home is at West Langdon. The family will be consulted before any decision is made. A replacement seat is being considered, possibly sited in a southfacing direction which offers views of the church and historic farm buildings.

East Langdon Village Pond and Highway Flooding— Cllr Shaw met with KCC Highways engineers to discuss the on-going flooding around the green. Options may include digging new soakaways on the green and cleansing the existing silt trap at the head of the Church Farm Mews pond. A project report is expected after preliminary test bores of the green are completed. The re-opening of an old run-off ditch at the junction of Waldershare Lane and Church Lane is not an option for KCC as the land is privately-owned although a local solution is a possibility.

<u>Martin Mill Parking issues</u> – No constructive responses have been received back from southeastern. The parish council is determined to hold southeastern to account for the parking issues and urge local residents to continue displaying the "Resident's Parking" notices to enable accurate parking surveys to be made.

KCC –Website hosting and creating an accessibility-compliant site. Several parish councillors recently attended a KALC seminar explaining the new legislation which come into force on 1st September 2020 for all local government public websites. KCC and other webhosting companies offer compliant services with a range of designs and support which the council will review before making a decision.

<u>KCC 20mph Speed Roundels markings in East Langdon</u>. Generally well received, with only one resident who questioned the adverse visual impact on the village environment.

5. HEALTH AND SAFETY

The true level of road traffic incidents occurring in rural lanes not being reported may be much higher than police statistics suggest. Parishioners are requested to report incidents to the clerk and an article will be placed in the next parish newsletter.

6. REPORTS

County and District Councillors

Cllr S Manion: KCC's 5 year plan is out for public consultation until 17th February.

An increase of 1.97% in Council Tax is being considered for the Kent Fire and Rescue Service in 2020-21.

Cllr O Richardson: It is hoped that the DDC draft Local Plan (HELAA) will be presented to parishes in February for consultation over a 6 week period. A meeting is being requested with southeastern to discuss the parking concerns at Martin Mill station.

Cllr M Bates. A revised Council Tax scheme is being considered to work alongside the Universal Credit system. Local Plan meetings to be held by DDC at the end of March. DDC car parking charges are being revised as follows: an increase in parking charge period from 5pm to 6pm. DDC car parks which are currently free in rural locations will move to a charge tariff of £1 minimum for 2 hours. DCC has deferred the decision to include the St Margaret's village car park in the new charging scheme following strong local protests. A full consultation will be launched in about 12 weeks before a final decision is made.

Resolution 20-01/02: That the financial statement for the period October – December 2019 be accepted as an accurate statement of accounts and signed by the chairman.

Proposed: Cllr B Price-Stephens Seconded: Cllr J Watson Resolution approved unanimously.

Budget Preparation for 2020-21 and Precept Demand

A budget of £18,200 had been set for the financial year 2020-21 at the December 2019 council meeting (Resolution 19-12/02). This budget was increased by £1520 on 2019-20 to reflect expected running costs, parish maintenance projects and new initiatives. Changes to legislation affecting the council's website compliancy and data protection are new expenditure areas as well as potential community works which may be required to supplement decreases in DDC and KCC funded services. Healthy parish council reserves will allow some unallocated reserves to be used to supplement the proposed budget, balance income being derived from the precept and VAT expenditure refund.

The precept tax base (the number of Band "D" equivalent properties in Langdon) for 2020-21 is 242.8, compared to last year's figure of 236.07. This is partly due to the additional housing at Long Hill Lane in East Langdon. Using this increase has allowed the parish council to set the parish Band "D" council tax at £62.21 as last year (0% change) whilst raising a precept of £15,104. The shortfall in the £18,200 budget figure being met from reserves (£2,085) and the predicted VAT refund (£1,000. Based on the above information a proposal to set the precept demand at £15,104.59 was considered.

Resolution 20-01/03: To set the annual precept for the financial year 2020-2021 at £15,104.59

Proposed: Cllr A Minns Seconded: Cllr S Willett Resolution approved unanimously.

The Parish Precept Demand Notice for £15,104.59 was authorised by the Chairman and Clerk ready for delivery to Dover District Council. Details of the 2020-21 budget and precept are in Appendix A and the parish council website.

Grants to Local Organisations. Application Notices will be placed in parish notice boards and on the website inviting parish organisations to apply for a grant of up to £250. Details are on the parish council website or from the clerk.
