# Monthly Report from DDC Cllr M Bates MEETING REPORT FOR EAST LANGDON PARISH COUNCIL ON 15<sup>th</sup> NOVEMBER 2021

#### **BINS**

The position has now stabilised to the point where the daily reports show that 100% of household, recyclable and garden waste collections are now taking place on the dates scheduled. There are occasional glitches, but these are being picked up the following day. Garden waste collections were also recommenced in October and are operating in accordance with scheduled collection times. The occasions when we are receiving complaints from residents have all but disappeared. However, this has only been obtainable through the drafting in of additional resources from outside the District and this, in the long term, is not sustainable. Consequently, there will be a final restructuring of collections schedules in March next year. To pilot the new programme a new schedule encompassing round changes for approximately 3000 communal and narrow access properties will commence shortly. All affected residents will receive a letter notifying them of the changes and this will be going out over the forthcoming two weeks.

#### **COMMUNITY GRANT**

One hundred organisations benefitted from the Winter Round of Community with a total amount £119,527.49 being awarded.

#### CHRISTMAS PARKING

To provide support to local businesses, I have just signed off on free parking in DDC car parks for Small Business Saturday on 4 December 2021. Furthermore, parking charges in Council-run car parks will not be enforced from 23 December 2021 to 28 December 2021 and 1 January 2022 to 3 January 2022.

#### **WISE**

The new enforcement agency commenced operations in the district on 18<sup>th</sup> October. Since commencing operations 297 Fixed Penalty Notices have been served on people dropping litter, of which 167 have been paid, and the enforcement officers have been making their presence known in areas where dog fouling has been taking place.

#### LOCAL ISSUES

# 1). West Side unadopted road.

Still ongoing. I have written to my colleague in KCC to see whether he can try and push this forward. Might be an idea to request a meeting with the headteacher of the primary school and see whether we can ask for her support particularly in relation to clearing the public footpath to the school.

#### 2). Southern Water and Waterworks Lane

Cllr Minns wrote on 4<sup>th</sup> November complaining that Southern Water were not in compliance with the traffic management plan. DDC Cllr Richardson has requested that the DDC enforcement team investigate and received the following response today:

"The developer has been reminded of the route that the construction traffic should be taking to and from the site, I have been assured that they are doing all they can to ensure the agreed route is being taken to and from the site (HGVs). The Planning Enforcement Team do not have the power to stop traffic from using the highway, land which is owned by a third party (KCC)."

I will speak to the developer again in the hope that this matter is resolved. If not, our only option is to consider a breach of condition notice which does not physically prevent the traffic from using the highways, if the notice is not complied with then we can consider prosecution, by which time the development could well be completed.
