4. MATTERS ARISING FROM THE MINUTES

<u>Westside/School Lane unadopted section</u> KCC Cllr S Manion has written to KCC Director of Education to seek help in the on-going lane maintenance.

<u>The Queen's Platinum Jubilee Celebrations June $2^{nd} - 5^{th}$ </u> A programme of events has been agreed. The planning committee has now been formed to action events and a letter will be sent to all Langdon households outlining the events on Sunday 5^{th} June Community Lunch. The parish council will invite parents of parish children under 16 to sign up for a free Jubilee commemoration mug as was done for the Diamod Jubilee back in 2012.

<u>Commonwealth Day 2022 14th March</u> Langdon Primary School's Year 6 pupils performed the "Raising of the Commonwealth Flag" and reading of the Affirmation at East Langdon Green. This short but notable public event is a community tradition which had been observed each year until Covid-19 restrictions prevented the parish council from organising the gathering. A letter has been sent to the school thanking the pupils for their participation.

5. HEALTH AND SAFETY

Neighbourhood Watch Nothing further received about re-establishing the scheme in Langdon. **Martin Gorse Southern Water Engineering Site** Of the 900 HGV vehicle movements so far, a small but significant number of contractors vehicles have not followed the designated routes, resulting in lane congestion and damage to resident's properties in Martin. Cllr A Minns will investigate the possibility of a road traffic order and appropriate signage to restrict HGVs.

6. REPORTS

KCC Cllr S Manion: KCC's new budget includes a modest increase of 2.99% with a priority to protect Social Care services. A road safety strategy is being considered by KCC for rural routes which could include reducing the national speed limit from 60mph to 40mph.

DDC Cllr O Richardson: The Dover Border Control Facility at Whitfield was signed off on 3rd March. The Bastion Point site works at the White Cliffs Business Park has started, as has the Dover Fastrack Bus Route construction including a new bridge across the A2.
